Nature of Ragging	Punishment
Teasing, embarrassing and humiliating	Imprisonment up to 6 months or fine up to Rs 1000/- or both
Wrongfully restraining or confining or causing hurt	Imprisonment up to 2 years or fine up to Rs. 5000/- or both
Assaulting or using criminal force or criminal intimidation	Imprisonment up to I year or fine up to Rs. 2000/or both
Causing death or abetting suicide	Imprisonment up to 10 years or fine up to Rs. 50000/- or both
Causing grievous hurt, kidnapping or abducting or rape or committing unnatural offence	Imprisonment up to 5 years or fine up to Rs. 10000/or both


