2. Implementation of e-governance in areas of operation Finance and Accounts

Employee salaries are paid digitally through banks. Major payments are never made using the cash system or offline methods. Only students use cash, a UPI, or online payment methods to pay their admission costs. Every scholarship is funded via the DBT online system. Students must have their account number connected to their Aadhaar and cell phone numbers in order to be eligible for scholarships.

The university decides on the admissions procedure. If admissions are handled online, students must apply online in order to be admitted. The application must come in person to the location of their choice for admission because the system is centralized. The admissions merit list is available on the college website. The college issues books in the library through a methodical software technique as well.

The University conducts examinations for both semester and annual credit. College fulfils its guidelines to the letter. The examination details for the 2019–2020 Covid-19 illness period was posted on the college website to assist students in preparing for their exams. The university also provided instruction on this.
